\$985,000 for Project Committee 2

Overview

Over the past few engineering committee meetings, we have updated the committee on the progress of the J.B. Latham Package B project as well as some of the challenges we have encountered on the project. As reported in the June 2021 Capital Improvement Construction Report and in Table 1 below, the Solids portion of the Package B project is nearly out of contingency. In addition, we have \$1,055,042 of Potential Change Orders in process that will exceed the remaining contingency. In order to prevent delays, we are requesting the approval of additional contingency for the Solids portion of the project.

The two major potential change orders are the MCC F1 Relocation (PCO 008 - \$350,000) and DAFT 1 and 2 Repairs (PCO 66 - \$300,000) and these are described in the accompanying PowerPoint to this Staff Report.

Fiscal Impact

As stated above, the current estimate for potential change orders is \$1,055,043. Significant contracted work is yet to begin and there may be additional change orders not yet identified and the cost of above identified potential change orders may vary as we progress. As a matter of procedure, all change orders against contingency are presented to the Engineering Committee and the Board for approval. The additional contingency will allow us to continue to direct work to be completed without causing delay to construction.

With the addition of the requested increase to the solids contingency, the total of the Package B Solids (3287-000) contingency will be \$1,657,400.

The recently approved Fiscal Year 2021/22 Capital Improvement Program Budget currently has \$3,100,000 for the Package B Solids Project (3287-000) and the increase in contingency would increase the FY 21/22 project budget by \$985,000 to \$4,085,000. The total Project contingency will increase to \$2,371,000, which will be 13.7% of the original construction contract.

Recommended Action: The Engineering Committee recommends to the PC 2 Board of Directors to approve the addition of \$985,000 of contingency to the J.B. Latham Package B Solids Project (3287-000) for a total Solids contingency of \$1,657,400 and to increase the project budget by \$985,000 to \$4,085,000 for the 21/22 FY.









Construction Management Services [Project Committee 2]

Overview

The scope for the construction management services includes inspection, document management, progress payment review, change order review, operations, and testing coordination. The original contractual end date was September 15, 2021. Currently approved change orders have extended the project to February 2022 and existing schedules and potential additional change orders are expected to take the project to the end of May 2022. Project detail is provided in the PowerPoint Presentation attached to Agenda Item 3 and that information will be covered by Staff at the meeting.

Due to the extension of the project schedule, Butier Engineers, the third-party Construction Manager for this project, has submitted an amended construction management services fee of \$612,715 to provide services through the end of May 2022.

Fiscal Impact

Table 1 shows the project allocation, and Table 2 shows the allocation by member agency for the Construction Management Services. The project is within budget and within the approved contingency.
