Summary

The initial 2-year term of the sodium hypochlorite (bleach) chemical contract with Olin Corporation ends on January 1, 2022. There are up to 2 annual renewals available with the contract. This chemical is necessary to disinfect recycled water and maintain compliance with air quality regulation for hydrogen sulfides in the foul air discharges from the foul air scrubbers within the wastewater treatments.

However, due to the substantial increases and fluctuations in trucking costs and raw materials prices for making bleach, Olin could only offer the extension with a 14-day price guarantee.

Because of the substantial proposed increases by Olin Corporation, on average of 33% over the current contract, Staff will continue to evaluate options in the coming year. At this time, the SOCWA Board is being requested to approve the 1-year contract extension with Olin Corporation for sodium hypochlorite as shown below, plus applicable fees and taxes, including applicable charges for split load deliveries:
