Items [Project Committee 15]

#### Overview

Several elements of the Coastal Treatment Plant were descoped for various reasons from the PCL construction contract. The SOCWA Engineering Committee was kept updated on these items and a presentation was given in January 2021. The presentation provided an overall project update and details on the items/reasons for removing them from the project. The major items removed were the new drainage pump station and new equipment for the West Secondary Sedimentation Basins.

PCL provided an estimate for a deductive change order that was significantly lower than expected. Through the several meetings, emails, and letters, SOCWA staff offered PCL to provide backup for additional costs and overhead for the descoped items. PCL rejected all offers and provided no additional backup costs. SOCWA staff, with guidance from legal counsel, issued a unilateral deductive change order for the remaining amounts to be billed less contractual overhead of 7.5%. This action brought PCL to the negotiating table and SOCWA and PCL worked out an agreement where Butier Engineers (BEI) would conduct a third-party review of the work and provide an estimated cost to complete the work. After review the parties were still approximately \$300,000 apart and after consideration of the limited opportunities PCL had to reduce its costs of equipment and personnel on the site, SOCWA negotiated to extend an additional \$100,000 payment for those costs to gain agreement on the value of the deductive change order.

PCL has agreed to the BEI cost estimate for the descoped items.

Table 1 below shows the descoped items, the credit issued in the deductive unilateral Change Order No. 27, the initial PCL proposed credit, and the Butier cost estimate for each item.

The PCL estimate is \$497,364 less than SOCWA Change Order No. 27; the Butier estimate is \$195,006 less than SOCWA Change Order No. 27 and \$302,358 more than the PCL estimate.

SOCWA staff believe the BEI cost is a fair estimate to use for the credit for the descoped items and have also gained agreement from PCL for use of this estimate. We are seeking approval from the PC 15 Board to approve the BEI cost estimate for calculating the total contract amount for PCL for the Coastal Treatment Plant Facility Improvements project. The difference between Change Order No. 27 and the BEI estimate of \$195,006 has been included as Change Order No. 46 on Agenda Item No. 5.

**Recommended Action:** Staff recommends that the PC 15 Board approve the cost estimate for descoped items for a total of \$1,005,182.06.

### Overview

The attached Capital Improvements report identifies the final change orders for the Coastal Treatment Plant Facility Improvements Project. All the change orders presented here (Change Orders 39 to 46 totaling \$410,0561) have been reviewed by the construction management and SOCWA engineering staff.

The project remains within the contingency of \$828,810 with the total amount of all additive change orders at \$780,013 or 94% spent.

Please note that Change Order No. 45 for \$100,000 was negotiated between PCL and the SOCWA General Manager. PCL had originally requested \$213,757 in compensation for 77 days of owner caused delay. Change Order No. 46 for \$195,006 is for the difference between the unilateral deductive Change Order No. 27 and the Butier Engineers estimate for the descoped items previously discussed in Agenda Item No. 4.

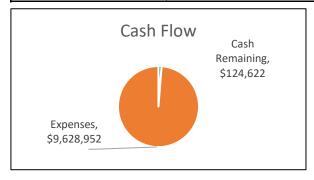

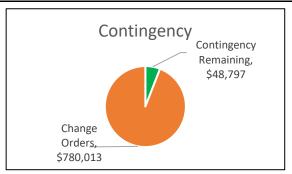

**SUBJECT:** Coastal Treatment Plant Facility Improvement Project Anticipated Budget

Adjustment [Project Committee 15]

#### Overview

SOCWA Staff are requesting approval of a budget increase of \$325,000 for the Coastal Treatment Plant Facility Improvements Project (3539-000) for a total Fiscal Year 2021/22 budget of \$2,825,000.

Although all contracts remain within the Board approved budgets and contingencies, the budget for the current fiscal year assumed more spending in the previous fiscal year than was realized. The budget also included an estimate for the descoped items at a slightly higher credit than what has been negotiated.

SOCWA Staff are currently estimating a FY 21/22 overage of about \$250,000 and are requesting an additional \$75,000 for a total increase of \$325,000 to cover any other unaccounted charges that may be remaining such as staff time and consultant fees.

**Recommended Action:** Staff recommends that the PC 15 Board approve a budget increase for Facility Construction Improvements (3539-000) by \$325,000 to \$2,825,000 for the 21/22 FY.
